Treasurer's Comment

In order for me to accomplish successfully the requirements of my position, it is imperative that I have access to timely financial information. The access to timely financial information is currently under the control of our property manager, Vesta Property Services, Inc. I have recently received the monthly financial statements for Avalon I, Avalon III and only the January month-end statements for Avalon Master Association. Because the finances of all four of our associations are intertwined, having only three of the four pieces of our financial picture makes it not possible to properly analyze our financial position as of March 31, 2023.

I understand that our property management company has had difficulty retaining accounting staff but has been hiring. I have been corresponding with the new accounting manager who has been working to get our financial records up to date. This is good news but in no way excuses our property management company for the extremely poor service we have had to suffer over the past several months.

Using the information that we do have, your president and former treasurer, Bob Carubia, and I have analyzed those statements and have found them wanting and filled with errors and unanswered questions. We have presented these concerns to our property manager and the new accounting manager. The new accounting manager has agreed to meet with Bob Carubia and me next week at a time and date yet to be determined. Based on communications that I have had with the new accounting manager, I am hopeful that the three of us will be able to agree on the appropriate steps needed to be taken to correct the issues we see.
